3.1 LTO- Wendy [1-5mins]

Wendy advised that Airedale Enterprise Services was the organisation chosen by residents to be the Local Trusted Organisation [LTO] for Keighley Big Local and, as such administers and accounts for the distribution of your funding, and/or delivers activities or services. Wendy provided everyone with details of Big Local expenditure to date. Summary; Income £20,000 in May 2013, £18,000 in December 2014 and £2,000 in December 2015. Total £40,000. Total expenditure as of January 11th was £36,928.37. Wendy explained the majority of this was salary for the development worker. An initial post of 9 month was followed by a second of 12 month. The post is 3 days per week. Approximately £5000 has been spent on consultation, micro projects and related costs since January 2015. There were some outstanding payments to Hainworth Wood Community Centre and KIVCA. These would be confirmed this week. Wendy confirmed this expenditure has not been drawn down from the £1Million allocated to the partnership to deliver the Big Local plan.

3.2 Development Worker- Shaun [1-5mins]

Shaun confirmed that his 12 month contract with KIVCA had ended. Budgets had been confirmed this week and sufficient funding was available to cover the costs of a Development Worker for the period January to March 2016. Shaun had accepted the offer of continuing to support the Partnership for this period as voted for, by the Partnership at the previous meeting.

3.3 Big Local Representative- Sam [1-5mins]

Sam explained her role as Big Local Representative for Keighley, a 'soft touch' role which involved promoting good practice, networking opportunity and an overview of the Big Local Programme.
